Once again, we are trying to make registration easier and quicker by offering registration on the website.

We were told that the conference fee will be slightly higher this year (isn't everything?), but the conference basically pays for itself (with some help of scholarship funds). Part of the increase is due to the Retreat Center providing a Friday noon meal and afternoon snacks for those arriving earlier on Friday. At this time, the amount of scholarship support is not known, but we anticipate it at a similar level as last year.

We are also fortunate to have travel arrangements for reduced airfares (10% if booked before March 28th and 5% after) through Travel-About, and company that employs one of the local Minnesota facilitators. Their (toll free number is 1800-808-0939).

As per tradition, the conference will run from noon on Friday, May 28th, through

lunch on Monday, May 31st. As happened last year, the Minnesota contingent will provide shuttle service to and from the conference site.

#### AVP USA ANNUAL MEETING Farmington, Minnesota May 25, 2003

The 2003 AVP USA annual meeting was held Sunday, May 25, 2003 at the Mount Olivet Retreat Center, 7984 257th St. West, Farmington, Minnesota. In attendance were about 80 AVP USA facilitators.

#### **MINUTES**

The 2002 minutes were accepted without change.

#### **OLD BUSINESS**

- The Restorative Justice committee was established last year. They will report during the committee reports.
- The International Travel Fund was spent during the year to assist those going to the International Conference in Nigeria.
- The Zell fund has been used 2-3 times. \$5,000 to bring exinmates to Virginia and \$6,000 used this year for about 21 scholarships. The rest went to AVP USA general fund.

#### **COMMITTEES**

Each committee was asked to give a brief synopsis of their committees work this past year, barriers encountered, and plans for the coming year. A more detailed committee report was attached to these minutes.

- Committee of Committees (presented by Diana Couch)–
  - o This committee consists of a representative from each committee and the current AVP USA officers and serves only to share information between committees, make recommendations and to nominate the new Vice-President.
  - Vice-President nomination was Ann Ward.
- Finance Committee (presented by Ann Ward)–
  - o The 2002 financial statement was reviewed and explained by Mike Leatherwood. Committees are reminded to submit their 2003 budget needs at this annual meeting.
  - ° The expanded Finance Committee has 3 grant writers and others with experience in managing budgets.
  - ° A fund-raising letter will be going out in the next couple of months.
  - Regarding financing for regions— Regional reps need to submit a equest to the Finance Committee of what is needed.
  - Tom Truitt, current AVP USA treasurer has stepped down from that position. Although he was unable to attend this meeting, his long term sup-



port and service was acknowledged by this group. An affirmation poster was posted to send to him.

- ° Nomination for Treasurer–Mike Leatherwood
- ° New co-chairs Ann Ward and Mike Leatherwood
- Communication Committee (presented by Diana Couch)—
  - Oatabase-Diana has taken over the complete database. Janet Lugo has had to withdraw from maintaining the database. Although she was unable to attend this meeting, her work developing and maintaining the database and transformer subscription list, was acknowledged. An affirmation poster was posted to send to her. The CLARG Committee is currently assisting Diana with updating the database.
  - ° Website-Rick Krouskop has continued adding to and maintaining the AVP USA website. Main contact information is being updated by the CLARG.
  - Transformer-Charles Oropallo, the Transformer editor, and the committee are brain-storming improvements that will bring down the production costs of the Transformer and increase subscriptions.
    - Suggestion was made from Steve Angel to send a copy of the Transformer to all who donate
    - Point of note was made by John Shuford that there may be some material in the Transformer that is not appropriate for nonfacilitators.
    - It was pointed out that each person, who completes a T4T and whose name is added to the database, receives a free one-year subscription.

#### alkans AVP Report John A. Shuford (Journeying John)

Dover, Delaware, USA

September 2003

AVP has had a presence in the Balkans for several years. Steve Angell made five trips, being accompanied by Marilyn Williams [Philadelphia], Sister Margaret McKenna [Philadelphia], Karin [England], Rick and Rachael Grier-Reynolds [Philadelphia] and Joe DiGarbo [Philadelphia]. Programs were set-up in Croatia and Serbia and trainings were done in Bosnia. Also, Andy Rose helped set-up a program in Macedonia.

Joe DiGarbo and I traveled to the Balkans in September with the primary purpose of helping develop a program in Bosnia and to do further trainings in Croatia. With the establishment of a program in Bosnia, there could be inter-country cooperation, fertilization and strengthening throughout the Balkans.

Joe had done all the planning with two groups in Bosnia, one in Gorazde and the other in Mostar. About a week before our departure, Joe received an email informing him that neither group had been able to organize a training, leaving us with only two trainings in Croatia. Joe emailed AVP in Beograd [Belgrade], Serbia to see if they could set-up trainings to make the trip more worthwhile. One of the Beograd



trainers, Jelena, contacted Sejo, a fellow peaceworker in Sjenica, a small mountain town in southern Serbia. Sejo told Jelena not to worry, he would arrange two trainings. Sejo coordinates Flores, an NGO which teaches computer skills in a town so poor it has no computers in the schools. The two AVP trainings would be for his students and teachers, a basic and a training for facilitators. This would allow them to share AVP with the town and region. With this news, Joe and I continued our preparations for the trip.

Our first stop was Sarajevo, Bosnia. Our contacts were friends of Ted Hermann: Zlatko and Lilijana of the Ombuds Office for Human Rights. These were great contacts because the said they would be willing to make arrangements for trainings in 2004. They liked what they saw in AVP and understood the need. Zlatko said that much of the world focus had shifted from Bosnia, so many of the NGO's had left. Much remained to be done with limited resources. As I walked the streets of Sarajevo, I could see the trauma on the faces, even through the smiles and laughter. There was so much pain in people's eyes, even the youth. Many of the buildings had been restored or rebuilt and many remained untouched, especially outside the city. It was very painful to drive for hours and see almost every home and building destroyed. And yet, the people were ebounding. There was hope among the horror – the men playing chess in the park, the old woman feeding the birds, the shops with everything Europe had to offer, the AFSC Garden Project bringing all ethnic groups together growing their own vegetables and so on.

From Sarajevo, we drove into the mountains [similar to the Appalachian Mountains] to Sjenica, a town of about 4000. We stayed in what had been a small resort hotel, which had not had enough spare parts for many years [common condition of many eastern block countries]. The workshop participants were very excited with wonderful energy. One of the first questions to me during the first break was what I thought about the American bombing of Beograd. I was not expecting this question and I could not respond as emotion overcame me. After about 30 seconds of deafening silence, I responded that I was saddened. disappointed ashamed. From that point on, there was a deep connection between us. That war seemed so far away from me, but it obviously wasn't for them. Jelena, the lead trainer, was in Beograd during the bombing and she said, "Why did you have to bomb Beograd? We were just about to get Milosevic out of power non-violently, then the bombing gave him an excuse to declare marshal law. He remained in office months longer that if you hadn't bombed." Fortunately the Serbs were angry with our government and not with us.

A valuable lesson learned from this training was that someone who teaches English may not be a good translator. Our translator spoke good English, but had difficulty translating what we said and was probably more interested in learning from the experience of the workshop than in translating. We finally allowed her to be a participant, which was not a problem, because there were a number of English speakers in the group. The participants were a mixture of Muslim and non-Muslim, which is what we had hoped for. Overall, the two workshops went very well and we all had a lot of fun.

Next, Joe and I drove through the mountains of Montenegro to the Adriatic Sea and Dubrovnik, an ancient walled city where we played tourist for a day. Then back to Sarajevo and up to Croatia, the most depressing drive of the trip. Several hours of destroyed homes and villages. When we arrived in Croatia, everything changed. It looked like a European country



as I had envisioned it. We were picked up at the border, where we left our rented car. and were driven to Pozega, a town of about 35,000. We did a basic training for teachers and counselors, which went very well. The two Croatian trainers did most of the workshop with assistance from Joe and me. The lead trainer, Magdalena, did all the arranging and was very competent. She, and her husband, Milan, then drove us to Popovaca and the Lipovica prison. Magdalena works as a psychologist in the prison system and had previously done workshops for her colleagues from around the prison system, and now wanted a Training for Facilitators. The participants were quite sophisticated and by the second day, it became clear Magdalena and Xenia could do it on their own. As a result, we no longer had comments translated for us, which allowed them to accomplish so much more. We have great hopes for what those trainers can accomplish in the Croatia prison system.

Joe and I plan to return next year to move the process along in Bosnia, with side trips to Serbia and/or Croatia. The people we met were very receptive and even hungry for what AVP has to offer. Since our return, we have received emails about further trainings they are doing as a result of our trip. What beautiful countries and beautiful and fun people. I look forward to returning.

Time was given for 'home' groups as a place to check in and share the day's events and in the evenings to we had some fun time to-



gether and heard reports from the AVP regions present. Then of course there were meal times and freshly baked muffins and cookies for morning & afternoon tea. There was a real sense of cross cultural sharing on many levels. Thank you to everyone for the continuous participation. (See the later reports for details).

There were two points of consensus that



arose from the big group.

- (i) That a letter be sent to AVP South Africa requesting to know if they might care to be the hosts for the next IG in 2006. That there be 3 months given for AVP/USA to consider this and if at that time they are unable to host, that this role then be passed over to AVP/USA.
- (ii) That we all prefer to have clear communication happening for AVP internationally and to aid this, we request that each country set up a single contact willing to receive and disseminate information and requests from other countries and to keep everyone informed of the opportunities to participate at an international level.

While written evaluations on the last day were not asked for, a sheet has been attached with this report. Your feedback would be appreciated and may be valuable to pass along to the next hosts to support their planning. The last day of the IG went by in a rush of last minute matters to attend to. For those of us remaining it was a fitting end to gracefully and gratefully share breath together one last time before departing.

So as we bid you all a fond and warm, if somewhat rainy, farewell. We trust that the heart of AVP has been strengthened in our being together and that each of you has been strengthened in your own heart also.

I can receive of others. No problem, no problem, no problem.


